

## **Privacy Policy for Nandi Jewellers**

At Nandi Jewellers, one of our main priorities is the privacy of our visitors. This Privacy Policy document contains types of information that is collected and recorded by Nandi Jewellers and how we use it.

If you have additional questions or require more information about our Privacy Policy, do not hesitate to contact us.

This Privacy Policy applies only to our online activities and is valid for visitors to our website and application with regards to the information that they shared and/or collect in Nandi Jewellers. This policy is not applicable to any information collected offline or via channels other than this website or application.

### **Privacy Policy**

Nandi Jewellers(“Nandi”, “We”, “Us”) is committed to the compliance of applicable Privacy Laws in the country where Nandi Jewellers’ product is distributed. Protecting the privacy and security of your personal data is of prime importance to Nandi Jewellers, therefore, we conduct our business by abiding by the laws applicable on data privacy and data security in the country where Nandi Jewellers’ product is distributed to you.

This Privacy Policy is intended to inform you about the personal data that is collected from you, how your personal data may be used and disclosed, how you can control the use of your personal data, and how your personal data is protected when you use the Nandi Jewellers Application or the application developed by a third party for Nandi Jewellers (“Application”). We do not sell or trade your personally identifiable information; however, we may share the same with third parties who assist us in conducting our business, operating our website/Application, or servicing you, so long as those parties agree to keep this information confidential.

## **What Information is collected about you?**

### **Information you provide directly:**

When you use certain functions provided by the Application, such as when you register for certain services, access, features or services, we may ask you to provide certain personal data such as name, contact number, pan and aadhar details, postal address, email address, username, password etc.

### **Information that is automatically collected when you visit the Application:**

1. When you download and visit the application, certain information may be collected automatically, which includes:
2. Your computer's Internet Protocol (IP) Address,
3. Your browser type and operating system,
4. Web pages and links you visit, advertisements you view,
5. Your bandwidth speed and information about the software programs that are installed on your computer,
6. Standard server log information

### **Information that we collect from other sources:**

We may receive information about you from publicly and commercially available sources (as permitted by law), which we may combine with other information we receive from or about you. We also may receive information about you from third-party social networking services when you choose to connect with those services.

### **How we use the information we collect:**

**General:** Nandi Jewellers may use the information collected from you to register you or your device for a Service, to provide a service or feature you request, to provide customized content and make recommendations based on your past activities on our Application.

**Advertisements:** Nandi Jewellers may use your information to provide you with product and service updates, newsletters and other communications about existing and/or new products and services by post, email, telephone, in-device messaging and/or text message (SMS), if you have provided your prior consent or we are otherwise permitted to do so under applicable law.

**Statistics and Research:** Nandi Jewellers may use your information to create user group profiles or segment data and to otherwise create anonymous, aggregated statistics about the use of our products, services and loyalty programs, which we may share with third parties and/or make available to the public.

**Product/Services Improvement:** Nandi Jewellers may use your information to improve and enhance existing Nandi Jewellers products, services and Applications and develop new offerings, recommendations, advertisements and other communications and learn more about customers' preferences in general.

**Publish your reviews, comments and content:** Where you have uploaded product reviews, comments or content to our websites or Application and made them publicly visible, Nandi Jewellers may link to, publish or publicize these materials elsewhere including in our own advertisements.

**To whom do we disclose your Personal Data:**

1. We may employ third party entities and individuals to facilitate our Services (e.g. maintenance, analysis, audit, marketing, and development). These third parties have limited access to your information only to perform these tasks on our behalf and are obligated to Nandi Jewellers, not to disclose or use it for other purposes. All of our approved third-party providers go through an extensive data protection compliance vetting process before being selected as a third party provider and are bound by all relevant data privacy laws, terms of confidentiality, and this Privacy Policy.
2. If you choose to use the Application, you will be asked to confirm acceptance of the third party developer user agreement and Nandi Jeweller's privacy policy.
3. There may be instances when we disclose your information to other parties to comply with the law or respond to compulsory legal process or to verify or enforce

compliance with the policies governing our Services or to protect the rights, property, or safety of Nandi Jewellers, or any of our respective affiliates, business partners, or customers.

**Your Choices:**

We offer a variety of choices about how we use your information. You can make choices about whether to receive promotional communications from us by following the unsubscribe instructions included in the communication. In addition, you can also generally make choices in your settings, or by visiting relevant links.

**Security:**

The security of your personal data is of great importance to us. We have put in place reasonable physical and technical measures to safeguard the information we collect in connection with the Services. However, please note that although we take reasonable steps to protect your information, no Application/website, Internet transmission, computer system or wireless connection is completely secure.

**Links to Other Web Sites:**

Nandi Jewellers Application may contain links to other websites. Nandi Jewellers is not responsible for the privacy practices or the content of other websites or applications.

On our Application, we may have links to other websites/ applications or you are referred to our Application through a link from another website or Application. We cannot be responsible for the privacy Policies and practices of other websites or applications. Such content is subject to their terms of use and any additional guidelines and privacy information provided in relation to that use on their website or application. We recommend that you check the policy of each website/application you visit to better understand your rights and obligations especially when you are submitting any type of

content on those third party website/application. Please contact the owner or operator of such website/application if you have any concerns or questions.

## **Log Files**

Nandi Jewellers follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.
